The revision of the ceiling of expenditure for payment of Food Packet Allowance to the Home Guards during their deployment on various festive occasions for duty beyond eight hours in a day was under active consideration of the Government.

After careful consideration and in partial modification of this Department Notification No. 1209/CD, dated 17-9-2011. Government have been pleased to revise the ceiling of expenditure from Rs 1.50 lakh to Rs 10.20 lakh per annum for payment of Food Packet Allowance to a maximum deployment of 3000 Home Guards (2800 Home Guards for seven days & 200 Home Guards for four days) in a year on various festive occasions for duty beyond eight hours in a day. The ceiling of Rs 10.20 lakh per annum for payment of Pood Packet Allowance shall not be extended under any circumstances.

The aforesaid revision of the ceiling of expenditure for payment of Food Packet Allowance to Home Guards shall come into force with immediate effect.

This has been concurred in by Finance Department vide their U.O.R No. 131-GS-I, dated 6-4-2013.
