Sub:-Disposal of appeal petition of Home Guards/ Ex.Home Guards by Deputy Commandant General, Home Guards as per Rule-3 (a) of Odisha Home Guards, (Appeal) Rules,1963.

On joining of Dr. Soumya Mishra, IPS as Addl. D.G of Police, F.S & HGs, Odisha, Cuttack, she has been assigned to perform the duties relating to all matters of Home Guards Organisation in addition to other duties vide this Directorate General Office order No. 5705/FS dated 28.06.2020.

Upon such assignment, she has been vested with the power of Deputy Commandant General, Home Guards, Odisha, Cuttack in place of I.G of Police, F.S, HGs & CD, Odisha, Cuttack.

As such all appeals made against an order of suspension, reduction in rank, dismissal or imposition of any fines etc. passed by Commandants of Home Guards shall be dealt with by Deputy Commandant General, Home Guards in the first instance instead of Commandant, General, Home Guards as per Rule 3 (a) (i) of Odisha Home Guards (Appeal) Rules,1963.

In this connection, Home Guards Circular Order No. 3/2018 dated 22.05.2018 stands repealed.


