Sub: Proposal for revision of rate of honorarium of Guest faculties in Odisha Fire and Disaster Response Academy, Bhubaneswar.

Sir,

In inviting reference to your Letter No. 5394/FPW, dtd. 12.08.2022 on the subject cited above and in supersession of this Department Letter No. 1489/CD, dtd. 19.08.2009, I am directed to convey the approval of Government for revision of rate of honorarium for Guest Faculties in Odisha Fire and Disaster Response Academy (OFDRA), Bhubaneswar as follows.

- 1. The honorarium for Guest Faculties per session of 60 minutes/ 75 minutes shall be Rs. 1000/- per session for Government Officers coming to OFDRA, Bhubaneswar and Rs. 1500/- per session for resource persons from non-Government sectors.
- 2. The resource persons in twin city Cuttack-Bhubaneswar, who use own conveyance shall be considered for payment of a lumpsu, of Rs. 300/- as a fixed travel allowance and those who come from outside Cuttack-Bhubaneswar by train/bus/air shall be paid the actual travel expenses.
- 3. OFDRA, Bhubaneswar shall maintain feedback from the trainee for different faculty including the guest faculty in the scale of 01 to 10 and empanelment of the faculty shall be done on the basis of such feedback.
- 4. This shall come into force from the date of its issue.
